Christ is Risen! Alleluia!

It was with sadness that I learned of the death of Pope Francis on Easter Monday. As the [Vatican News said on the day of his death](#), *“Of the many encyclicals, Apostolic Exhortations, and open letters that Pope Francis produced during his twelve-year pontificate, it’s probably fair to say that none made as much of an impact as [Laudato si’](#). Published in 2015, this encyclical letter was the first ever written by a Pope on the subject of the environment—and it went on to make waves both inside and outside the Church. ... *Laudato si’* also had an impact on policy. ... What we need, he says, is “a new way of thinking about human beings, life, society and our relationship with nature”.*

At the conclusion of his letter, Pope Francis shared two prayers. Below is one of them: **A Prayer for our Earth.**

*All-powerful God, you are present in the whole universe  
and in the smallest of your creatures.*

*You embrace with your tenderness all that exists.  
Pour out upon us the power of your love,  
that we may protect life and beauty.  
Fill us with peace, that we may live  
as brothers and sisters, harming no one.  
O God of the poor,  
help us to rescue the abandoned and forgotten of this earth,  
so precious in your eyes.  
Bring healing to our lives,  
that we may protect the world and not prey on it,  
that we may sow beauty, not pollution and destruction.  
Touch the hearts  
of those who look only for gain  
at the expense of the poor and the earth.  
Teach us to discover the worth of each thing,  
to be filled with awe and contemplation,  
to recognize that we are profoundly united  
with every creature  
as we journey towards your infinite light.  
We thank you for being with us each day.  
Encourage us, we pray, in our struggle  
for justice, love and peace.*

Let us join with God in the holy work of loving, protecting, healing, restoring, and renewing all things.



## Divestment Summit Recording



On March 25 and 26th, 2025, the California-Nevada Conference of the United Methodist Church held a Fossil Fuel Divestment Summit, geared specifically toward Conference financial officials and agencies.

**The recording of the two day summit is now available on the conference YouTube channel.**

This Summit was the outcome of a Recommendation on fossil fuel divestment as a response to climate change that was passed in June 2024, at the California-Nevada Annual Conference Session. The purpose of the Summit was to: 1) to “uphold best practices for investment management,” 2) to “identify sound financial strategies to screen out fossil fuels from our conference investment portfolios,” and 3) to “make a report, including recommendations, to the 2025 Annual Conference.”

Topics covered included fossil fuel divestment as a moral and spiritual challenge, how other churches and annual conferences have divested from fossil fuels, how divestment from fossil fuels contributes to climate justice, comparative risks and returns of low carbon funds vs. investments in fossil fuel corporations, financial reasons to divest from fossil fuels, and how to divest from fossil fuels and reinvest in a fiscally and socially responsible way.

## Resilience Hubs



**Resilience** to climate change means preparing for the impacts of climate change and building capacity to bounce back from those impacts. Some conferences and churches are building Resilience Hubs. Some call them Community Lighthouses.

**What is a Resilience Hub?** United Methodist Creation Justice Movement describes an emerging vision of a network of churches serving as hubs of resilience and refuge, based on “refugia” which is a biological concept describing places in nature that survive and even thrive amid severe disturbance. Resilience Hubs are *“energy efficient, community-serving places that have the resources and connections needed to support community members both in moments of crisis and in the everyday.”* These hubs can make us more resilient and responsive in times of disruption, while also offering connection, belonging, support, and love to our neighbors at all times.



## Cap and Trade



A situation to keep watching:

The White House said in an executive order on April 8th that it would target state environmental regulations for “threatening national security.” Gov. Gavin Newsom and legislative leaders said on April 15th that they will try to extend cap-and-trade, California’s flagship environmental regulation program.

The Cap-and-Trade Regulation establishes a declining limit on major sources of green house gas emissions throughout California, and it creates a powerful economic incentive for significant investment in cleaner, more efficient technologies. The Program applies to emissions that cover approximately 80 percent of the State's green house gas emissions.
